### Management System Certification

An Intertek Certified organization, under a UKAS accredited scheme, may use the UKAS accreditation logo and symbols only in conjunction with Intertek's symbol on the organisation's stationary and literature, and its advertising, subject to UKAS's and Intertek's conditions for use for the logos and symbols.

The UKAS accreditation symbol shall be reproduced:

- In either black and white or the colour scheme: Purple / White (Pantone 2685 C)
- Alternatively, the *national accreditation symbols* may be printed or displayed in a single colour, which is the predominant *ink* colour of the document, or, in the case of a pre-printed letterhead, the predominant *ink* colour of the letterhead.
- In a size (normally a minimum height of 20mm) that makes all features of the symbol distinguishable, without distortion of its proportions or infilling

The size of the UKAS symbol must not exceed the size of Intertek's symbol.

The organisation may not place the UKAS accreditation symbol in isolation from Intertek's symbol.

Notes:

1. The Intertek ISO 9001 symbol is used as an example of format. ISO 14001, OHSAS 18001 etc. symbols are available on request.

#### SSIP scheme (UKAS accredited)

All use of the SSIP logo and brand must be for SSIP membership purposes only. Suppliers are entitled to use the designated SSIP logo during any period of registration with a valid member scheme.
